Generally:

- 1) Hereafter "faculty"
- 2) Cross and underline what applies
- 3) In case a language exam is required and an applicant may select a language, he/she enters a language, which he/she will take entry examination from
- 4) The second and third area of study are entered according to faculty instructions
- 5) Acquired academical degree - abbreviation
- 6) An applicant is not required to enter the data as it is personal and his/her approval is necessary.
- 7) The format of two figures is needed for date and month of birth (e.g. January-"01", December-"12") and last two figures for the year of birth (e.g. 1978-"78")
- 8) The address for mail delivery.
- 9) The name of a secondary education institution, where secondary education was completed.
- 10) The area of study completed and its JKOV code as well as the area of study completed and its KKOV code is entered (KKOV differs from JKOV by a capital letter at the last position). Both names of areas of study and codes are stated in the leaving certificate. This field is not applicable for applicants who are not coming directly from secondary schools or who took school leaving examinations in a previous year or before.
- 11) INI-identification number of the institution stated in the paper of the institution foundation. The data is stated in school certificates. This field is not applicable for applicants who are not coming directly from secondary schools or who took school leaving examinations in a previous year or before.
- 12) The faculty that stated selected courses of the study programme, which an applicant applies for, marks the item
- 13) The order of courses is not stated. It is recommended to list courses in the same order as they are listed in secondary school certificates.
- 14) Applicants who take the school leaving examination in the current year, will enter their last half-year school results. Applicant coming from more-year secondary schools will enter their school results for last four years.
- 15) This field is not applicable for applicants who take school leaving examinations in a current year.
- 16) Average study results are calculated and stated with two figures after the decimal point.
